Direct the Innocence Clinic and to provide Educational Services and Training to law students in the Innocence Clinic at the Texas A&M University - Law School campus located in Fort Worth, TX for the period of September 1, 2016 through August 31, 2017.

Scope of Work

The Provider must be a non-profit organization that has extensive experience in the evaluation, investigation, and litigation of claims of actual innocence.

The Provider will provide a qualified, experienced person or persons to supervise and work directly with law students on cases assigned to them in the clinic during the fall, spring and, summer terms of the academic year 2016-17.

The Provider will provide a qualified, experienced person or persons to teach the classroom component of the Innocence Clinic and one related course approved by the School of Law. Such person or persons will need to satisfy Texas A&M University hiring policies and protocols and for adjunct faculty.

Each instructor or clinic supervisor provided by the Provider is required to have a J.D. degree, to be licensed to practice law in the State of Texas, and to have substantial experience in evaluating, investigating, and litigating claims of actual innocence.

The Provider will have qualified staff to conduct intake of claims and to screen correspondence from persons claiming actual innocence to ensure that claims of innocence reviewed by Innocence Clinic students are claims that are potentially actionable.

The Provider must have the capability to engage qualified experts to assist in the evaluation and investigation of cases that focus on forensic issues, prosecutorial misconduct, and other ways of proving innocence.

The School of Law must be afforded the capability of monitoring classes to assure quality control of teaching methods and the student experience.

The instructors must abide by Texas A&M School of Law academic standards with respect to attendance and grading requirements.
