This section does not impose a duty on the Trille IV-D agency to collect information to send to the comproduer to withhold a payment to a business entity. The Title IV-D agency and other affected agencies are encouraged to develop a system by which the Title IV-D agency may identify a business entity. The Title IV-D agency and other affected agency may identify a business entity that is ineligible to receive a state payment under Subsection (a) and to ressure that a state payment under Subsection (a) and to ressure that a state payment under and only if the Title IV-D agency, comproblee, and other affected agencies determine that it will be cost-effective.

#### 14. ALTERNATIVE DISPUTE RESOLUTION

The dispute resolution process provided for in Chapter 2260 of the Texas Government Code shall be used, as further described herein, by Texas A&M. University, and the Vendor to attempt to resolve any claim for breach of contract made by Vendor.

- Vendor's claim for breach of this contract that the parties cannot resolve in the ordinary course of business shall be submitted to the negotiation process provided in Chapter 2250, subchapter B, of the Texas Government Code. To initiate the process, Vendor shall submit written notice, as required by subchapter B, to Philip A, Ray, Assistant Vice President of Strategic Sourcing and Contract Administration. Said notice shall also be given to all other representatives of Texas AAM University and Vendor otherwise entitled to notice under the parties' contract. Compliance by Vendor with subchapter B is a condition precedent to the filing of a contested case proceeding under Chapter 2260, subchapter C, of the Texas Government Code is Vendor's sole and exclusive process for seeking a rememby for any and all alleged breaches of contract by Texas AAM University if the parties are unable to resolve their disputes under subparagraph (a) of this paragraph. Vendor's claim for breach of this contract that the parties cannot resolve in
