Furnish and Installation of Custom Acoustical Treatments, in order to lower the current reverberation time in the Cox-McFerrin Men's Practice Court on the campus of Texas A&M to a much more manageable level.

The current reverberation time in this area is approaching four seconds. This combined with typical activities experienced in a gymnasium environment can quickly amplify the associated noise level to an uncomfortable level, making verbal communications a challenge and fatiguing those involved at any accelerated rate. The new treatment shall lower the existing numbers of most all tested frequencies below two seconds.

The installation will include a total of 200 custom fabricated, suspended acoustical baffles at ceiling level throughout the area. They will be installed horizontally, with the long dimension parallel to the ground/ceiling. The goal is to have the bottom of the baffles approximately on the same plane as the bottom of the steel supports so there will be no interference with existing lights. These baffles will be finished in black to better blend with the surrounding ceiling color.

Installation shall include the following equipment along with the necessary installation labor, cable, connectors and hardware for a complete and professional installation.

- -200 Custom Suspended Acoustical Baffle 4' x 6' x 2" black finish
- -Installation Hardware and Materials
- -All labor and expenses

This project shall be considered a "turnkey" project that includes all aspects of the installation.

The project must be professionally designed, furnished, installed and warranted for a minimum period of one (1) year from invoice date against defects in materials and installation workmanship.

All installations shall be completed in approximately one (1) week after work begins.
