Texas A&M University, Athletics is seeking pricing for the Furnish and Installation of a Truss Structure for the Fan Zone for 2019 football season at Kyle Field Stadium located on the campus in College Station, TX.

The truss structure shall be utilized to create an entrance to the fan zone, located in the Zone Plaza on the far west end near Pickard pass. The structure shall be 100' wide by 16' tall with a clearance of 11'. The structure will need to withstand wind and weather elements normal to our region. The structure shall be free standing and not attached to Kyle Field.

The structure shall allow for branding opportunities on each end that are 5' wide and across the top at 5' tall.

Additional Specifications:

- 12" x 12" EP Series Box Truss
- Compatible with industry standard plated truss bolt pattern
- Grade 8 bolts included with 8 washers and nuts
- 6061-T6 aluminum
- 2" O.D. x (2mm) main chords
- 1" O.D. x (3mm) diagonals
- Shall consist of the following 12" x 12" and corner blocks:
 - *2' – EP 1202
 - *3' – EP 1203

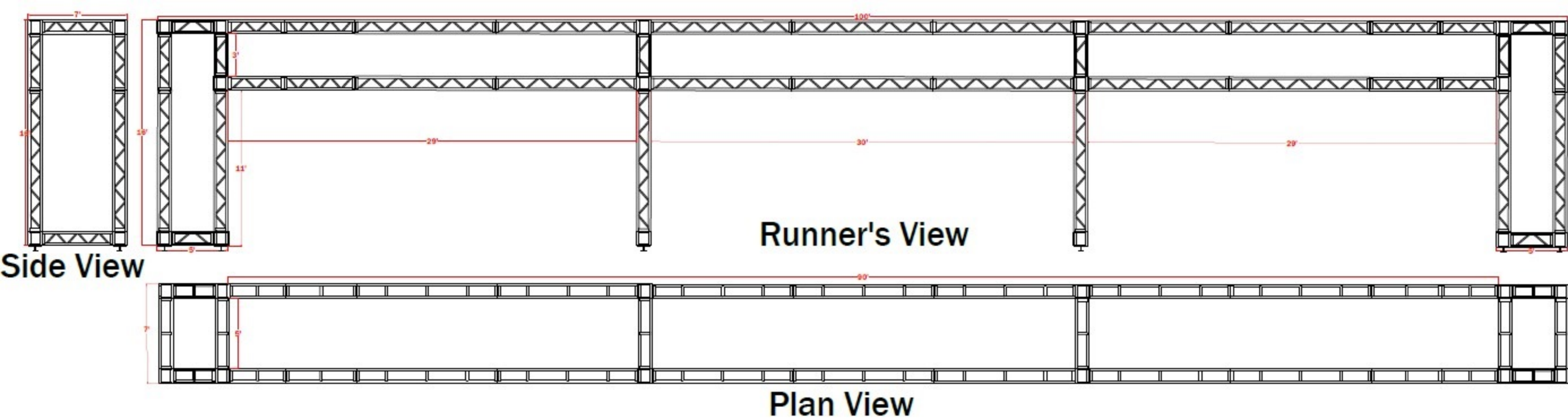
Insurance
