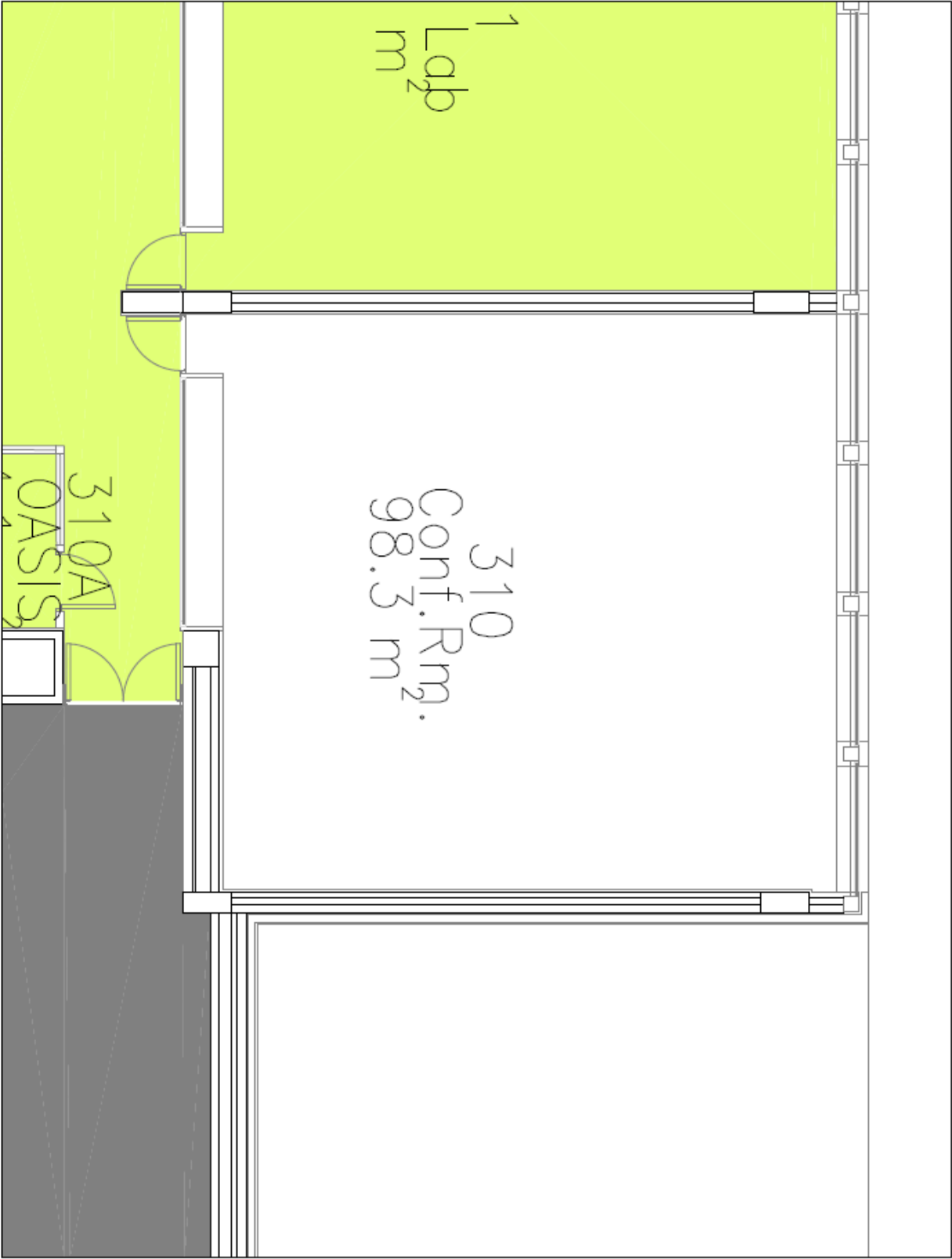

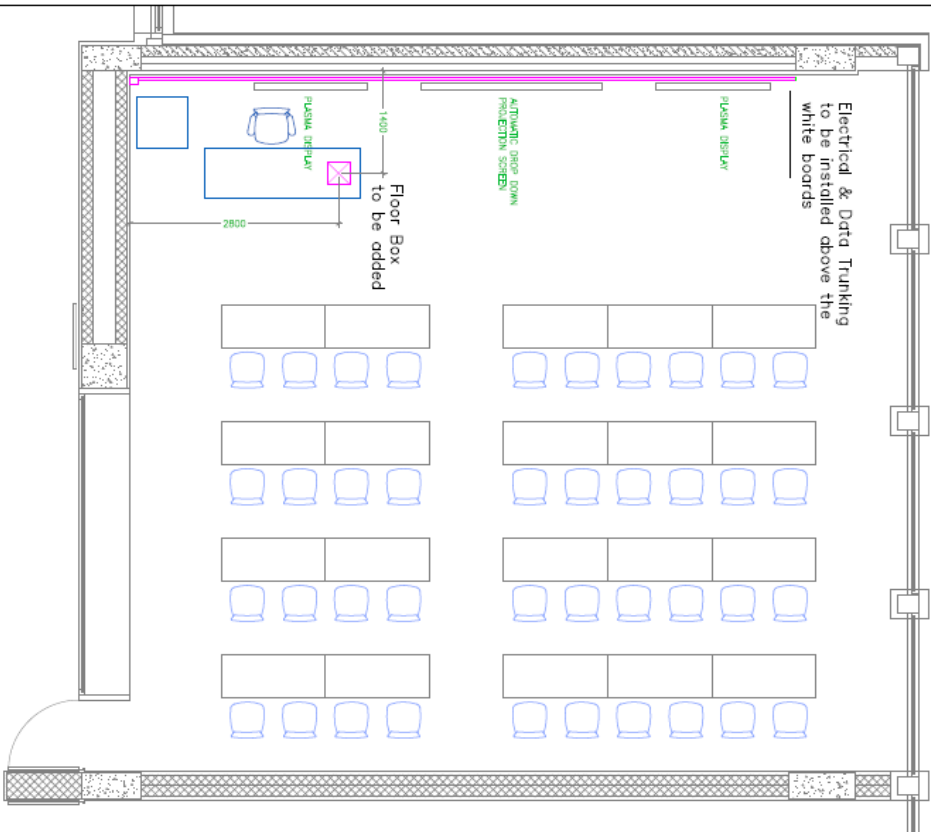




Elevation 1
