RENEWAL AGREEMENT**

THIS RENEWAL AGREEMENT (this "**Renewal Agreement**"), entered into as of April 1, 2019 (the "**Renewal Effective Date**") by and between 12Twenty, Inc., a Delaware corporation ("**12Twenty**"), and The Texas A&M University, an agency of the State of Texas ("**University**"), is made in connection with that certain Service Order and Master Services Agreement (collectively, the "**Agreement**") previously entered into by 12Twenty and University. Capitalized terms not otherwise defined in this Renewal Agreement will have the meanings given to them in the Agreement. 12Twenty and University agree as follows:

1. Expiration of Initial Term. The Initial Term of the Agreement, which commenced on March 31, 2017 will (unless extended or renewed) expire on March 31, 2019. Pursuant to Section 4.1 of the Agreement, the Agreement may be renewed for additional periods (if any) as agreed to the parties in writing.
2. Renewal Terms. By this Renewal Agreement, the parties agree to renew the Agreement for an additional three-year period, such that this first Renewal Term will commence as of the Renewal Effective Date and continue in effect until March 31, 2022, unless earlier terminated as provided for in the Agreement. Upon the expiration of this initial Renewal Term, and of each Renewal Term thereafter, the Agreement will automatically renew for successive Renewal Terms of three years each until terminated in accordance with Section 4 of the Agreement.
3. No Other Changes. Except as specifically amended by this Renewal Agreement, the Agreement will remain in full force and effect in accordance with its terms. This Renewal Agreement may be executed in multiple counterparts, each of which will be an original, and all of which taken together will constitute a single instrument. Execution and delivery of this Renewal Agreement may be evidenced by PDF or facsimile transmission.

IN WITNESS WHEREOF, the authorized representatives of the parties are executing this Renewal Agreement intending for it to be effective as of the Renewal Effective Date.
