Terms

1. Renewal Term.

- 1.1 To allow for ongoing renewal negotiation discussions, the parties agree to a renewal term of three months beginning on October 16, 2022 ("Renewal term Start Date") and ending on January 15, 2023 ("Renewal Term") for the Products and Facilities listed in the spreadsheet in Exhibit 1 to this Amendment.
- 1.2 Upon expiration of the Renewal Term, the Agreement will automatically renew for additional two-year periods unless either party provides with written notice of nonrenewal at least 90 days prior to expiration of the then-current term.
- 2. **Extension Fees.** The additional license fees for the Renewal Term are \$36,564.46 and are due on the Amendment Effective Date.
- 3. **Migration Amendment Incorporation.** The terms of InterQual Connect Amendment No. 31699, effective December 17, 2019, are incorporated into this Amendment as if fully set forth herein.
